# Processing purposes:

The purposes are the preparation and implementation of the event, e.g. administration of the reporting system, preparation and management of start and participant lists, evaluation of the services for the preparation of a list of results, publication of results and reports, press and public relations.

## Legal bases:

The basis for these processing activities is mainly the fulfillment of the contract in accordance with Art. b DSGVO, legal obligations in accordance with Art. c DSGVO (e.g. BAO, state laws on tax law) as well as occasionally our legitimate interest under Art. f DSGVO.

#### Eligible interests:

Our legitim interests in accordance with Art. f DSGVO is to enable the event within the limits of our statutory tasks and purposes of Austrian Athletics. As a part of the legitim interest, we document the event with photos and reports and publish them on our website. Processing within the legitim interest takes place only after careful



consideration with the interests of persons affected by this processing. We comply with all data protection-related regulations and pay attention to the observation of the rights and interests of the parties concerned. If you believe that you are infringed or restricted by this data processing, we have carried out within your rights and/or interests, please let us know - we will stop further processing as soon as possible.

#### Recipients or categories of recipients:

For the purposes set out above, we may forward data of data subjects to commissioned third parties who work for us in fulfilling these purposes (IT service providers, media services and media companies for the purpose of press and public relations, timekeeping companies, etc.). Data will not be transmitted to third countries or international organisations.


#### Duration of storage/criteria for determining the duration:

We store and process the data for the duration resulting from the respective processing method. We take care to store data only for the fulfilment of the purposes necessary.

#### Affected rights:

You have the right of access, rectification, deletion, restriction of processing, in certain cases a right of objection to the processing, as well as the right of data portability. You have the possibility of contradiction against processing in accordance with Art. 21 sec. 1 DSGVO. In this case, we will stop processing, unless there are reasons for further processing for the exercise, assertion and defence of legal claims.
